

**PENNSYLVANIA BUSINESS BROKERS ASSOCIATION**  
**APPLICATION FOR MEMBERSHIP**

The PBBA Bylaws define members as "Regular Members" and "Associate Members". In both instances the actual member is the firm that the business broker, intermediary, or associate owns or is affiliated with.

REGULAR Members (Brokers / Intermediaries) are Broker firms providing full time business brokerage services. ASSOCIATE Members are lenders, attorneys, accountants, financial planners and other professionals involved in business sale transactions.

The Regular (Broker / Intermediary) firm members get one vote on PBBA business matters, regardless of the number of employees or associates in that firm. However, all employees or associates of Regular or Associate member firms, are welcome to participate in PBBA's educational meetings.

MEETINGS, EDUCATIONAL COURSES AND WORKSHOPS are held at least twice a year, usually on a Thursday and Friday in April and October. The course and meeting locations move to accommodate the members. Meeting dates, locations and programs are posted at [www.PennBBA.com](http://www.PennBBA.com).

MEMBERSHIP YEAR is on a calendar year basis. January 1 through December 31.

APPLICATION FEE (one time up-front fee) of \$100 per firm. In addition there are annual dues.

ANNUAL DUES vary from year to year. If you join prior to the April PBBA meeting there is no pro-ration; on or after the April meeting the annual dues are pro-rated at 50% of the annual dues. Contact the Treasurer for amount.

You MUST have this form signed by two existing PBBA members who recommend your firm for membership.

Then mail this form, bus card and brochure to the PBBA Treasurer with your Application Fee and Annual Dues.

The membership committee and then the PBBA Board will review your application and vote on your application.
